2. The 28th Equivalence Committee in its Resolution No.2 has resolved as follows:-

1. B.Sc. (Physical Education Health Education and Sports) awarded by Avinashilingam Institute for Home Science and Higher Education for Women (Deemed University), Coimbatore.	Not Equivalent
2. BPE (Bachelor of Physical Education) awarded by Annamalai University.	Accepted as Higher Qualification
3. BPES (Bachelor of Physical Education and Sports Sciences) awarded by Annamalai University.	Accepted as Higher Qualification
4. B.Sc. (Physical Education) awarded by Manonmaniam Sundaranar University.	Not Equivalent
5. MPES degree obtained without BPES Degree awarded by Annamalai University and Pondicherry University.	To be considered as Higher Qualification subject to confirmation of recognition by the University Grants Commission
6. Certificate Course in Physical Education one year duration. Karnataka State	Not Equivalent
7. Certificate Course in Physical Education two year duration. Tamil Nadu State	Equivalent
