1. Write short notes on the following.

- (a) Estate Officer.
- (b) Affected family in Land acquisition.
- (c) Small and Marginal Farmers.
- (d) Transferred territory.
- (e) Minor minerals, Mineral oil and notified minerals.
- (f) Adulterated food.

2. Say True or False in the following incidents and also quote the authority

(10 × 2 = 20)

- (a) The Distress under Revenue Recovery Act shall be made only after sunrise and before sunset.
- (b) At the time of sale of distrained property, where the purchaser failed in the payment of the purchase money, the property shall be resold. When the property, on the second sale, sell for a higher price than at the first sale. The difference or increase shall be property of Government.
- (c) Fasli year starts from April First day of previous year and ends in March 31st of succeeding year.
- (d) Village account number 2 i.e Adangal is an exclusive register to show the details of Patta holding in a village.
- (e) Village account number 1 shows the cultivation pattern of the village every month.
- (f) Jamabandhi is being conducted based on financial year to settle village accounts annually.
- (g) Village account no. 20 contains the details of Rainfall and water available in irrigation tanks utilised for cultivation in the village.

- (h) Beriz deductions is an allowance admissible to religious institutions.
- (i) A building measuring 50 sq.m and is used as hotel has been sealed by the Tahsildar, citing the reason that the hotel administration has not applied for and taken licence under public building licensing act 1965. Tahsildar is empowered to seal the building in this instance.
- (j) The Registrar of Births and Deaths has authority to refuse to take the information of incident of birth and death, citing the reasons that the information is not in writing and in prescribed format.
3. Narrate the procedure involved in eviction of a person who is unauthorisedly occupying a highly objectionable Government land again after having been evicted already adopting due process of law. (10)
4. Describe the procedures involved in recovery of Revenue by attaching a landed property under TN Revenue Recovery Act 1864. (10)
