- The institution shall run the R.Ed., course only in Special Education (MR) and it should not conduct any other squartional programmes
- 2. Qualified teachers should be appointed.
- 3. The Management should not appoint any teacher whose certificates had been cancelled or who has been convicted for offence involving moral turp titude.
- 4. The Management should run the training programme in accordance with the norms prescribed by Rehabilitation Council of India and the approval shall be withdrawn if the norms of Rehabilitation Council of India are not followed.

- 6. The Institute should have a basic infrastructure facilities required for starting such training programme.
- 4. The Director of Collegiate Education is requested to conduct examination and issue certificate to these who pass out of the Institution successfully.
