3. The admission to Physical Certificate Verification and Counselling is purely provisional, subject to verification and acceptance of the documents in support of the claims made in his/her online application in respect of Age,

Gender, Communal Category, Persons Studied in Tamil Medium, Destitute Widow, Differently Abled Person, Ex-Servicemen, Educational Qualification Only after verification of the claims with the original certificates, his/her eligibility will be decided for admission to next stage of selection. If he/she does not produce the required certificates or if he/she does not satisfy the eligibility criteria, his/her online application will be rejected and his/her provisional admission will be cancelled.

4. Mere inclusion of the Register Numbers of candidates in the above list will not imply that his/her candidature has been fully considered for selection. The provisional admission of candidates to Physical Certificate Verification and Counselling does not confer any right for selection and their selection will also be, subject to the availability of vacancies in their respective reservation categories, when they reach their turn as per their rank position and they are not assured of their selection.
