- 4. The candidates can download their Memorandum for Admission to Physical Certificate Verification and Counselling / Physical Certificate Verification from the Commission's Website and should attend with all the relevant documents in original on the prescribed date and time without fail. Candidates who have failed to attend Physical Certificate Verification and Counselling /Physical Certificate Verification on the scheduled date and time will not be considered for the next stage of selection.
- 5. The admission of the candidate to **Physical Certificate Verification** and **Counselling /Physical Certificate Verification** is purely provisional, subject to verification and acceptance of the documents in support of the claims made in his/her online application in respect of Age, Gender,

Communal Category, Persons Studied in Tamil Medium, Destitute Widow, Differently Abled Person, Ex-Servicemen, Educational Qualification, Technical Qualification, etc. Only after verification of the claims with the original his/her eligibility will be decided for admission certificates. Counselling/next stage of selection process. After verification of the original certificates, the eligible candidates alone will be admitted for counselling (if applicable) to be held on the same day itself. If he/she does not produce the required certificates or if he/she does not satisfy the eligibility criteria, his/her online application will be rejected and his/her provisional admission to Physical Certificate Verification will be cancelled.
