- 2. Intimation regarding Physical Certificate Verification and Counselling will be made through the Commission's website, SMS and e-mail through registered mobile number and email ID only. No individual communication shall be sent to the candidates by post.
- 3. The candidates can download their Memorandum for Admission to Physical Certificate Verification and Counselling from the Commission's Website and should attend with all the relevant documents in original on the prescribed date and time without fail. Candidates who have failed to attend Physical Certificate Verification and Counselling on the scheduled date and time will not be considered for the next stage of selection.
- 4. The admission of the candidate to Physical Certificate Verification and Counselling is purely provisional, subject to verification and acceptance of the documents in support of the claims made in his/her online application in respect of Age, Gender, Communal Category, Persons Studied in Tamil Medium, Destitute Widow, Differently Abled Person, Ex-Servicemen, Educational Qualification, Technical Qualification, etc. Only after verification of the claims with the original certificates, his/her eligibility will be decided for admission to Counselling/next stage of selection process. After verification of the original certificates, the eligible candidates alone will be admitted for counselling to be held on the same day itself. If he/she does not produce the required certificates or if he/she does not satisfy the eligibility criteria, his/her online application will be rejected and his/her provisional admission to Physical Certificate Verification and Counselling will be cancelled.
- 5. Mere inclusion of the Register Numbers of candidates in the above list will not imply that his/her candidature has been fully considered for selection. The provisional admission of candidates to Physical Certificate Verification and Counselling does not confer any right for selection and their selection will also be, subject to the availability of vacancies in their respective reservation categories, when they reach their turn as per their rank position and they are not assured of their selection.

6. The post, Department / Board / Corporation / Authority and the unit

once selected by the candidate will not be changed under any circumstances.

Candidates who have participated and once selected a post in the counselling will

not be allowed to participate in the counselling / further selection process for

other posts.

Commission and subject to the final orders to be passed by the Hon'ble High

Court of Judicature at Madras in the WPs and other cases pending on the files of
