However, the Commission provides the additional facility to the candidates by informing the above said date(s), event(s) and intimation relating to, Physical Certificate Verification via SMS and e-mail through their registered Mobile Number and e-mail ID. Candidates are directed to watch the Commission's website/Twitter/Telegram Channel periodically for all updates and intimations. The Commission shall not be responsible if the communication does not reach the applicant due to incorrect / invalid e-mail ID /mobile number and failure / delay in delivery of SMS /e-mail to the candidates due to any reason including technical issues. Any representation from the candidates for non-receipt of SMS or e-mail will receive no attention.

3. Mere inclusion of the Register Numbers of candidates in the above list will not imply that his/her candidature has been fully considered for selection. The provisional admission of candidates to Physical Certificate Verification does not confer any right for selection and their selection will also be, subject to the availability of vacancies in their respective reservation categories, when they reach their turn as per their rank position and they are not assured of their selection.

4. The candidates are provisionally admitted to Physical Certificate Verification in the ratio of 1:1.2 for all categories.

5. The candidates can download their Memorandum for Admission to Physical Certificate Verification from Commission's Website and should attend with all the relevant documents in original on the prescribed date and time without fail. **Candidates who have failed to attend Physical Certificate Verification on the scheduled date and time will not be considered for the next stage of selection.**

6. The admission of the candidate to **Physical Certificate Verification** is purely provisional, subject to verification and acceptance of the documents in support of the claims made in his/her online application in respect of Age, Gender, Communal Category, Persons Studied in Tamil Medium, Experience, Educational Qualification, Technical Qualification, etc. Only after verification of the claims with the original certificates, his/her eligibility will be decided for admission to next stage of selection process. After verification of the original certificates, the eligible candidates alone will be admitted for next stage of selection. If he/she does not produce the required certificates or if he/she does not satisfy the eligibility criteria, his/her online application will be rejected and his/her provisional admission to Physical Certificate Verification will be cancelled.

7. The admission of the above candidates to the Physical Certificate Verification is purely provisional subject to the decision of the Commission and subject to the final orders to be passed by the Hon'ble High Court of Judicature at Madras in the WPs and other cases pending on the files of the Hon'ble High Court, Madras/Madurai Bench of Madras High Court, if any, relating to this recruitment.

The candidates who had appeared for written examination was held from 09.11.2024 F.N. and 12.11.2024 A.N. and whose Register Numbers are not found in the above list have not been admitted to the Physical Certificate Verification for the post of Motor Vehicle Inspector - Grade II (Post code: 2119).
