2. The Physical Certificate Verification will be held on 28.08.2025 at the Office of the TNPSC, No.3, TNPSC Road, Chennai-600 003. Intimation regarding Physical Certificate Verification will be made through the Commission's website, SMS and email through the registered mobile number and e-mail ID only. No individual communication shall be sent to the candidates by post.

- 3. The candidates can download their Memorandum for Admission to Physical Certificate Verification from the Commission's Website and should attend the Physical Certificate Verification with all the relevant documents in original on the prescribed date and time without fail. Candidates who fail to attend Physical Certificate Verification on the scheduled date and time will not be considered for the next stage of selection.
- 4. The admission of the candidates to Physical Certificate Verification is purely provisional, subject to verification and acceptance of the documents in support of the claims made in his/her online application in respect of Age, Gender, Communal Category, Educational Qualification, Service Qualification, Experience, etc. Only after verification of the claims with the original certificate, his/her eligibility will be decided for admission to next stage of selection process. If he/she does not produce the required certificates or if he/she does not satisfy the eligibility criteria, his/her online application will be rejected and his/her provisional admission to Physical Certificate Verification will be cancelled.
- 5. Mere inclusion of the register numbers of candidates in the above list will not imply that his/her candidature has been fully considered for selection.
- 6. The provisional admission of candidates to Physical Certificate Verification does not confer any right for selection and his/her selection will also be, subject to the availability of vacancies in their respective reservation categories, when they reach their turn as per their rank position and they are not assured of their selection.
- 7. The candidates who have appeared for Written Examination on 04.01.2025 FN & AN (Descriptive Type) to the post of Assistant Section Officer in Secretariat (Other than Law and Finance Departments) in Combined Civil Services Examination- Group VA Services and whose register numbers are not found in the above list have not been admitted to the Physical Certificate Verification for the said post.
- 8. The admission of the above candidates for Physical Certificate Verification is purely provisional subject to the decision of the Commission and subject to the final orders to be passed by the Hon'ble High Court of Judicature at Madras in the

W.Ps and other cases pending on the files of the Hon'ble High Court, Madras / Madurai Bench of Madras High Court, if any relating to this recruitment.

- 9. Candidates who have been admitted for Physical Certificate Verification are not assured to be admitted for next stage of selection.
- 10. Candidates who have been admitted for Physical Certificate Verification are hereby instructed to watch constantly the Commission's website without fail regarding place, date and time of Physical Certificate Verification.
