2. All the candidates mentioned above are admitted provisionally for **Direct Physical Certificate Verification** subject to production of required documents in prescribed format. If he/she does not produce the required documents or if he/she does not satisfy the eligibility criteria, his/her online application will be rejected and his/her provisional admission to Physical Certificate Verification will be cancelled.

4. Intimation regarding Physical Certificate Verification and Counselling will be made through the Commission's website, SMS and e-mail through the registered mobile number and e-mail ID only. No individual communication shall be sent to the candidates by post.

5. The candidates can download their Memorandum for Admission to Physical Certificate Verification and Counselling from the Commission's Website and should attend the Physical Certificate Verification and Counselling with all the relevant documents in original on the prescribed date and time without fail. **Candidates who fail to attend Physical Certificate Verification and Counselling on the scheduled date and time will not be considered for the next stage of selection.**

6. The admission of the candidates to Physical Certificate Verification and Counselling is purely provisional, subject to verification and acceptance of the documents in support of the claims made in his/her online application in respect of Age, Gender, Communal Category, Persons Studied in Tamil Medium, Differently Abled Person, Educational Qualification, etc. Only after verification of the claims with the original certificate, his/her eligibility will be decided for admission to Counselling. After verification of the original certificates, the eligible candidates alone will be admitted to counselling to be held on the same day itself. If he/she does not produce the required certificates or if he/she does not satisfy the eligibility criteria, his/her online application will be rejected and his/her provisional admission to Physical Certificate Verification and Counselling will be cancelled.

7. Mere inclusion of the register numbers of candidates in the above list will not imply that his/her candidature has been fully considered for selection. The provisional admission of candidates to Physical Certificate Verification and Counselling does not confer any right for selection and their selection will also be, subject to the availability of vacancies in their respective reservation categories and subject/qualification category, when they reach their turn as per their rank position and they are not assured of their selection.

8. The candidates are provisionally admitted to Physical Certificate Verification (II Phase) and Counselling for the post of Sub-Inspector of Fisheries in the ratio of 1:10 for all the categories after excluding the candidates who were already summoned for the PCV held on 18.07.2025.

9. The admission of the above candidates to the Physical Certificate Verification and Counselling is purely provisional subject to the decision of the Commission and subject to the final orders to be passed by the Hon'ble High Court of Judicature at Madras in the WPs and other cases pending on the files of the Hon'ble High Court, Madras/Madurai Bench of Madras High Court, if any, relating to this recruitment.

10. The candidates who had appeared for written examination on 07.02.2023 F.N. & A.N. and whose Register Numbers are not found in the above list have not been admitted to the Physical Certificate Verification and Counselling relating to the post of Sub-Inspector of Fisheries.
