The candidates who have appeared for Written Examination on 11.01.2020 FN & AN to the Post of Assistant Section Officer (Translation) in Tamil Development and Information Department in the Tamil Nadu Secretariat Service (2018-2019) and whose register numbers are not found in the above list have not been admitted to the Original Certificate Verification / Counselling for the said post.
- 4. The admission of candidates to Original Certificate Verification / Counselling is provisional subject to verification and acceptance of their claim in their online applications such as Date of Birth, Gender, Community, Educational qualification, PSTM etc. through Original documents. If any of their claims are found to be false or incorrect, their provisional admission to Original Certificate Verification / Counselling will be cancelled and they will not be admitted to the Counselling.
- 5. After verification of original Certificates, the eligible candidates alone are admitted for Counselling to be held on the same day itself.
- 6. The Candidates can download their Notice for admission to original Certificate Verification / Counselling from the Commission's Website and should attend the Certificate Verification / Counselling with all the relevant documents in Original on the prescribed date and time without fail. Candidates who fail to attend Certificate Verification / Counselling on the scheduled date and time will not be considered for the next stage of selection.

The provisional admission of candidates to original Certificate verification / Counselling does not confer any right for selection and their selection will also be subject to availability of vacancies in their respective reservation categories, when they reach their turn as per their rank position and they are not assured of their selection.
