Commission in its Notification No.33/2022, dated 15.11.2022 has invited application from the candidates for the direct recruitment to the post of '**Assistant Professor of Psychology cum Clinical Psychologist**' included in the Tamil Nadu Medical Service.

1) Now, the Government in its letter No.43540/AA1/2021-4, dated 02.12.2022, has stated that the educational qualification for the said post has been amended vide G.O.Ms.No.422, Health & Family Welfare Department, dated 12.11.2007. Accordingly, under the Heading Educational Qualification in para 5(B) the expression mentioned in the said Notification for the post of '**Assistant Professor of Psychology cum Clinical Psychologist**' included in the Tamil Nadu Medical Service shall be read as follows:-
