- 1. After Onscreen Certificate Verification, the list of eligible candidates for Oral Test will be published subsequently in the ratio of 1:2/1:3.
- 2. Mere inclusion of register number of a candidate will not imply that his/her candidature has been fully considered for next stage of selection.
- 3. The candidates whose register number is found in the above list have been provisionally admitted to Onscreen Certificate Verification based on the marks obtained by them in the examination (Computer based Test), rule of reservation of appointment and other conditions stipulated in the notification for the said recruitment.

The admission of candidates to Onscreen Certificate Verification is provisional subject to verification and acceptance of claims as made in their respective online application with regard to Age, Educational Qualification, Communal category, Differently Abled category, Experience and PSTM status etc., through original documents. If any of the claims in the online application are found to be false or incorrect, their online application will be rejected and their provisional admission to Onscreen Certificate Verification will be cancelled and they will not be admitted to the next stage of selection.

The admission of the above candidates to the Oral test is purely provisional subject to the decision of the Commission and subject to the final orders to be passed in W.A(MD)NO.181 of 2023 and C.M.P(MD) No.2247 of 2023 and other cases, relating to this recruitment if any, pending on the files of the Hon'ble High Court of Judicature at Madras/Madurai Bench of Madras High Court.
