The admission of the above candidates to the Onscreen Certificate Verification is purely provisional subject to the decision of the Commission and subject to the final orders to be passed by the Hon'ble High Court of Judicature at Madras in the WPs and other cases pending on the files of the Hon'ble High Court, Madras/Madurai Bench of Madras High Court, if any, relating to this recruitment.
5. Candidates who have been admitted provisionally to the Onscreen Certificate Verification are hereby advised to upload the scanned copy of all the relevant documents without fail. Failure to upload even any one of the essential documents will result in their non-admission to the next stage of selection and rejection of their online application.

6. The Candidates admitted for Onscreen Certificate Verification are not assured to be admitted for next stage of selection.

Candidates who have been admitted for Onscreen Certificate Verification are hereby advised to watch constantly the Commission's website regarding mode, place, date and time of original certificate verification without fail.
