The admission of the candidate with the following register number to certificate verification for Oral Test is purely provisional subject to verification / acceptance of his/her documents; Educational qualification/Equivalence of qualification etc. Only after verification, his/her eligibility will become final for admission to Oral Test (interview). If he/she does not produce the required certificates or if he/she does not satisfy the eligibility criteria his/her provisional admission to Oral Test will be cancelled. Mere inclusion of candidate in this list

will not confer any right on the part of candidate to claim for participation in Oral Test. The Certificate Verification will be held on **19.01.2016** and Oral Test will be held on **25.01.2016**

Notes:

1. Mere inclusion of the Register Numbers of candidates will not imply that their candidature has been fully considered for Oral Test.
2. The candidates whose Register Numbers are found in the above list have been admitted provisionally to the Oral Test based on the marks obtained by them in the Written Examination, Educational Qualification possessed by them and with reference to the rule of reservation of appointments. The admission of candidates to Oral Test is provisional subject to verification and acceptance of the claim in their online applications towards Age, Educational Qualification, Community etc, through original documents. If any of their claims are found to be false or incorrect, their provisional admission to Certificate Verification/Oral Test will be cancelled and their application will be rejected.

The admission of the above candidates to the Certificate Verification/Oral Test is purely provisional subject to the decision of the Commission and subject to the final orders to be passed by the Hon'ble High Court of Judicature at Madras in the WPs and other cases pending on the files of the Hon'ble High Court, Madras/Madurai Bench of Madras High Court, if any, relating to this recruitment.

Candidate who has been admitted provisionally to the Certificate Verification/Oral Test is hereby advised to attend the Certificate Verification/Oral Test with all the relevant documents in original, without fail. Failure to produce even any one of the essential document will result in his/her non-admission to the Oral Test.
