A list of candidates provisionally admitted to Certificate Verification for Oral Test for appointment by direct recruitment to the posts of Librarian / Assistant Librarian in various services was published in the Commission's website on 20.04.2016 based on the results of the written examination conducted by the Commission on 01.08.2015 FN & AN and 02.08.2015 FN.

During Certificate Verification held on 09.05.2016 and 10.05.2016 the eligibility of some candidates have changed, few candidates have absented themselves and application of a candidate has been subsequently rejected. Consequently, the candidates with the Register numbers mentioned in the annexure have not reached the zone of selection / have been deleted / rejected for the reasons given thereof.

In order to substitute candidates in the place of absentees during Certificate Verification and also in the place of candidates who are not reaching the zone of selection for provisional admission to Certificate Verification for Oral Test due to changes in the eligibility status at the time of verification of original certificates conducted on 09.05.2016 & 10.05.2016, apart from the candidates who had already attended the Certificate verification and found eligible for respective standard of posts of Librarian and Assistant Librarian, the candidates with the following register numbers are hereby admitted provisionally to the Certificate Verification for Oral Test in respect of the following posts.

4. **Candidates who have been admitted provisionally to the Certificate Verification for Oral Test are hereby advised to attend the Certificate Verification for Oral Test with all the relevant documents in original, without fail. Failure to produce even any one of the essential document will result in their non-admission to the Certificate Verification for Oral Test.**
