List-III of 17 candidates under Open Market category and 826 candidates under Departmental Category provisionally admitted to Certificate Verification for appointment by direct recruitment to the post of **Junior Inspector of Co-operative Societies in the Co-operative Department in the Tamil Nadu Co-operative Subordinate Service included in Combined Civil Services – III (Group-III A service)** based on results of the written examination conducted by the Tamil Nadu Public Service Commission on 03.08.2013 FN was published on 10.11.2016.

During the 3<sup>rd</sup> Phase of Certificate Verification held from 25.11.2016 to 02.12.2016, 13 candidates under Open Market category and 50 candidates under the Departmental Category had absented themselves. Further 706 candidates were found ineligible under Departmental Category. It has therefore been decided by the Commission to admit the candidates to 4<sup>th</sup> Phase of Certificate Verification at the ratio of 1:4 for open market category.

Hence, apart from the candidates who had already completed the certificate verification and found eligible, the candidates with the following register numbers are hereby admitted provisionally to the certificate verification under Open Market Category for the said post. The certificate

verification will be held on **07.02.2017**, at the office of the Tamil Nadu Public Service Commission, Frazer Bridge Road, Chennai – 600 003

After completion of certificate verification in different phases till the availability of required number of candidates for admission to Oral Test in open market category, the list for provisional admission to oral test will be published separately for open market category and departmental category.

As announced earlier in the lists dated 05.01.2016, 20.05.2016 and 10.11.2016 the Certificate Verification / Counselling for appointment by direct recruitment to the Non-Interview posts viz. Store Keeper, Grade-II in Industries and Commerce Department and Store-Keeper in Employment and Training (Training Wing) Department will be held after finalizing the selection to the post of Junior Inspector of Co-operative Societies in the Co-operative Department.

#### **Notes:**

1. Mere inclusion of the Register Numbers of candidates will not imply that his/her candidature has been fully considered for Oral Test.
2. The candidates whose Register Numbers are found in the above list have been admitted provisionally to the Certificate Verification based on the marks obtained by them in the Written Examination, Educational Qualification possessed by them and with reference to the rule of

reservation of appointments. The admission of candidates to Certificate Verification is provisional subject to verification and acceptance of the claim in their online applications towards Age, Educational Qualification, Experience, Community etc, through original documents. If any of their claims are found to be false or incorrect, their provisional admission to Oral Test will be cancelled and they will not be admitted to Oral Test.

3. The admission of the above candidates to the Certificate Verification is purely provisional subject to the decision of the Commission and subject to the final orders to be passed by the Hon'ble High Court of Judicature at Madras in the WPs and other cases pending on the files of the Hon'ble High Court, Madras/Madurai Bench of Madras High Court, if any, relating to this recruitment.
4. Candidates who have been admitted provisionally to the Certificate Verification are hereby advised to attend the Certificate Verification with all the relevant documents in original, without fail. Failure to produce even any one of the essential document will result in their non-admission to the Oral Test.
