- 8. The candidates whose Register Numbers are found in the above list have been admitted provisionally to the Physical Certificate Verification and Counselling based on their rank position, rule of reservation of appointments, number of vacancies and other conditions stipulated in the Notification.
- 9. The admission of the above candidates to Physical Certificate Verification is provisional subject to verification and acceptance of their claim in the online applications in respect of Date of Birth, Educational/Technical Qualification, Age, Community, PSTM, etc. If any of their claims are found to be false or incorrect, their provisional admission to Physical Certificate Verification will be cancelled and they will not be admitted to the next stage of selection.
