2. Intimation regarding Physical Certificate Verification will be made through the Commission's website, SMS and e-mail through registered mobile number and email ID only. No individual communication shall be sent to the candidates by post.

3. The candidates can download their Memorandum for Admission to Physical Certificate Verification from the Commission's Website and should attend with all the relevant documents in original on the prescribed date and time without fail.

Candidates who have failed to attend Physical Certificate Verification on the scheduled date and time will not be considered for the next stage of selection.

4. The admission of the candidates to Physical Certificate Verification is purely provisional, subject to verification and acceptance of the documents in support of the claims made in his/her online application in respect of Age, Gender, Communal Category, Persons Studied in Tamil Medium, Destitute Widow, Differently Abled Person, Ex-Servicemen, Educational Qualification, Technical Qualification, etc. Only after verification of the claims with the original certificates, his/her eligibility will be decided for admission to next stage of selection process. If he/she does not produce the required certificates or if he/she does not satisfy the eligibility criteria, his/her

online application will be rejected and his/her provisional admission to Physical Certificate Verification will be cancelled.

5. Mere inclusion of the Register Numbers of candidates in the above list will not imply that his/her candidature has been fully considered for selection. The provisional admission of candidates to Physical Certificate Verification does not confer any right for selection and their selection will also be, subject to the availability of vacancies in their respective reservation categories, when they reach their turn as per their rank position and they are not assured of their selection.

6. The admission of the above candidates to the Physical Certificate Verification is purely provisional subject to the decision of the Commission and subject to the final orders to be passed in the WPs and other cases pending on the files of the Hon'ble High Court, Madras /Madurai Bench of Madras High Court, if any, relating to this recruitment.

The candidates who had appeared for written examination from 14.10.2024 FN & AN to 23.10.2024 FN & AN (CBT mode) (excluding 19.10.2024, 20.10.2024 and 25.10.2024), 26.10.2024 FN (OMR method) and 26.10.2024 AN (Descriptive Type) and whose Register Numbers are not found in the above list have not been admitted to the Physical Certificate Verification relating to the post mentioned above.
