If he/she does not produce the required certificates or if he/she does not satisfy the eligibility criteria, his/her online application will be rejected and his/her provisional admission to Counselling will be cancelled.

The provisional admission of the candidates to Physical Certificate Verification-cum-Counseling does not confer any right for selection and their selection will also be subject to availability of vacancies in their respective reservation categories, when they reach their turn as per their rank position and they are not assured of their selection.
