

## Tourist Officer included in the Tamil Nadu General Service Notification No: 03/2023 LIST-OT

The list of register number of candidates provisionally admitted to Onscreen Certificate Verification in the ratio of 1:4 for the post of **Tourist Officer** included in the Tamil Nadu General Service was published on the Commission's website on 07.03.2024 based on the results of Written Examination (Descriptive Type) conducted by the Commission on 10.06.2023 FN & AN and 11.06.2023 FN & AN.

Based on the outcome of Onscreen Certificate Verification, the register number of candidates mentioned below has been **provisionally** admitted to Oral Test in the ratio of 1:3 based on the marks obtained by them in the said examination and with reference to rule of reservation of appointments. The Oral Test will be held on <u>03.09.2024</u> at the office of the Tamil Nadu Public Service Commission, TNPSC Road, Chennai - 600 003.

The candidates should attend the Oral Test with all original certificates in support of the claims made in their online application. The above details will be made available in the Commission's website and the candidates will be informed of the above fact only through SMS and e-mail accordingly. Individual Communication regarding the date and time of Oral Test will not be sent to the candidates by post.

No individual communication shall be sent to the candidates by Post. Candidates

are directed to watch both the Commission's website and X account periodically for all updates and intimations. The Commission shall not be responsible if the communication does not reach the applicant due to incorrect / invalid e-mail ID /mobile number and failure / delay in delivery of SMS / e-mail to the candidates due to any reason including technical issues. Any representation from the candidates for non-receipt of SMS or e-mail will receive no attention.

## NOTE:

- 1. Mere inclusion of the register number of the candidates does not imply that his / her candidature has been fully considered for next stage of selection.
- 2. The candidates whose register number are found in the above list have been provisionally admitted to the Oral Test based on the marks obtained by them in the written examination (Descriptive Type) and with reference to the rule of reservation of appointments.
- 3. The admission of candidates to the Oral Test is provisional subject to verification and acceptance of the claims as made in their respective online application with regard to Age, Educational Qualification, Technical Qualification, Communal category, Gender etc., through original documents. If any of the candidate's claims is found to be false or incorrect, their online application will be rejected and their provisional admission to the Oral Test will be cancelled and they will not be admitted to the next stage of selection.
- 4. The candidates who have appeared for the said written Examination and whose register number is not found in the above list have not been admitted to the Oral Test for the said recruitment.
- 5. The admission of the above candidates to the Oral Test is purely provisional subject to the final orders to be passed in W.A. (MD) No.181 of 2023 and CMP (MD) No.2247 of 2023 and other cases relating to this recruitment, if any, pending on the files of the Hon'ble High Court of Judicature at Madras / Madurai Bench of Madras High Court.
- 6. The candidates who have been admitted provisionally to the Oral Test are hereby advised to attend the same with all the relevant

documents, in original without fail. Failure to produce even any one of the essential documents will result in their non-admission to the next stage of selection.
