**COMBINED CIVIL SERVICES EXAMINATION-I (GROUP-I SERVICES)
(NOTIFICATION NO.04/2024)
LIST-PHYSICAL CERTIFICATE VERIFICATION AND
ORAL TEST (PHASE-II)**

In the Counselling held on 09.05.2025 for appointment by direct recruitment to the posts included in Combined Civil Services Examination-I (Group-I Services), out of 90 vacancies notified in the said recruitment, 89 vacancies have been filled and one vacancy in BC(W)(SLD/MD) category for the post of Deputy Collector in the said recruitment was unfilled due to paucity of eligible candidates.

Therefore, the register number of one candidate (due to paucity of candidates) provisionally admitted to Physical Certificate Verification and Oral Test (Phase-II) for the said unfilled vacancy, in the ratio of 1:3, based on the results of Main Written Examination conducted by the Commission from 10.12.2024 to 13.12.2024 FN and other conditions stipulated in the notification for the said post is mentioned below. **The Physical Certificate Verification and Oral Test (Phase-II) will be held on 30.06.2025** at the office of the Tamil Nadu Public Service Commission, TNPSC Road, Chennai – 600 003.

Further, the candidate should attend the Physical Certificate Verification and Oral Test (Phase-II) with all original certificates in support of the claims made in his / her online application for the said recruitment. Individual intimation regarding the date and time of Physical Certificate Verification and Oral Test (Phase-II) will not be sent to the candidate by post. The candidate will be informed of the above

fact only through SMS and e-mail through his / her registered mobile number and e-mail ID. The candidate is directed to watch the Commission's website, 'X' account, Telegram channel and WhatsApp channel periodically for all updates and intimations. The Commission shall not be responsible if the communication does not reach the applicant due to incorrect / invalid e-mail ID / mobile number and failure / delay in delivery of SMS / e-mail to the candidates due to any reason including technical issues. Any representation from the candidate for non-receipt of SMS or e-mail will receive no attention.

NOTE :-

1. **Mere inclusion of the register number of the candidate in the above list will not imply that his / her candidature has been fully considered for Physical Certificate Verification and Oral Test (Phase-II) for the said recruitment.**
2. The admission of candidate to Physical Certificate Verification and Oral Test (Phase-II) is provisional subject to verification and acceptance of the claims in his / her online application towards Age, Educational Qualification, Gender, Community, PSTM, Differently Abled Category, etc., through original documents. Any discrepancy between the details as given in the online application and the documents submitted shall result in the summary rejection of candidature after due process.
3. The candidates who have appeared for the Main Written Examination and whose register number is not found in the above list, have not been admitted to Physical Certificate Verification and Oral Test (Phase-II) for the said recruitment.
4. The admission of the above candidate to Physical Certificate Verification and Oral Test (Phase-II) is purely provisional subject to the decision of the Commission and subject to the outcome of final orders to be passed in W.P.(MD) Nos.15812, 19953, 21042 of 2024, W.A.No.3444 of 2024, W.A.(MD) No.181 of 2023 and

CMP(MD) No.2247 of 2023 and other cases, if any, pending on the files of the Hon'ble High Court of Judicature at Madras/Madurai Bench of Madras High Court relating to this recruitment.

5. Candidate who has been admitted provisionally to the Physical Certificate Verification and Oral Test (Phase-II), is hereby advised to attend the same with all the relevant documents in original, without fail. Failure to produce even any one of the essential documents will result in his / her non-admission to Physical Certificate Verification and Oral Test (Phase-II) for the said recruitment.
