Mere inclusion of the register numbers of candidates in the list does not confer any right on the part of candidate for participation in oral test.

**Notes:-**

- 1 Mere inclusion of the register numbers of candidates in the above list will not imply that his/her candidature has been fully considered for next stage of selection.**
- 2 The candidates whose register numbers are found in the above list have been admitted provisionally to the certificate verification and oral test based on the marks obtained by them in the written examination and with reference to rule of reservation of appointments.
- 3 The admission of candidates to certificate verification and oral test is provisional subject to verification and acceptance of the claims in

their online applications towards Age, Educational Qualification, Community, Ex-servicemen Status, PSTM status etc, through original documents. If any of their claims are found to be false or incorrect, their provisional admission to certificate verification and oral test will be cancelled.

- 4 The candidates who have appeared for written examination and whose register numbers are not found in the above list have not been admitted to the certificate verification and oral test.
- 5 The admission of the above candidates to the certificate verification and oral test is purely provisional subject to the decision of the Commission and subject to the final orders to be passed by the Hon'ble High Court, Madras/Madurai Bench of Madras High Court, if any, relating to this recruitment.
- 6 Candidates who have been admitted provisionally to the certificate verification and oral test are hereby advised to attend the certificate verification and oral test with all the relevant documents without fail. Failure to produce even any one of the essential documents will result in their non-admission to the next stage of selection.
- 7 The list of register numbers of candidates who were admitted to certificate verification and who have not been considered for provisional admission to oral test and the reasons therefor have been mentioned in the Annexure to this list.
