The admission of the above candidates to Oral Test is purely provisional subject to the final orders to be passed in the writ petitions in W.P.Nos.4048 and 4054 of 2023 and other cases relating to this recruitment, if any, pending on the files of the Hon'ble High Court of Judicature at Madras/Madurai Bench of Madras High Court.
6. Candidates who have been provisionally admitted to the Oral Test are hereby advised to attend the Oral Test with all the relevant documents, in original, without fail. Failure to

produce even any one of the essential documents will result in their non-admission to the next stage of selection.
