Individual communication regarding the date and time of oral test will not be sent to the candidates by post.

Any representation from the candidates for non-receipt of SMS or e-mail will receive no attention."

- 2. The candidates whose register numbers are found in the above list have been provisionally admitted to the Oral Test based on the marks obtained by them in the Written Examination (Computer Based Test) and with reference to the rule of reservation of appointments.

The admission of candidates to Oral Test is provisional subject to verification and acceptance of the claims as made in their online application towards Age, Educational Qualification, Communal category, Differently Abled Category, Experience, PSTM Status etc., through original documents. If any of their claims are found to be false or incorrect, their online application will be rejected, their provisional admission to Oral Test will be cancelled and they will not be admitted to the next stage of selection.

- 4. The candidates who have appeared for Computer Based Test and whose register numbers are not found in the above list have not been admitted to the Oral Test.
- 5. The admission of the above candidates to the Oral test is purely provisional subject to the decision of the Commission and subject to the final orders to be passed in W.A(MD)NO.181 of 2023 and C.M.P(MD) No.2247 of 2023 and other cases, relating to this recruitment if any, pending on the files of the Hon'ble High Court of Judicature at Madras/Madurai Bench of Madras High Court.
- 6. Candidates who have been admitted provisionally to the Oral Test are hereby advised to attend the Oral Test with all the relevant documents, in original without fail. Failure to produce even any one of the essential documents will result in their non-admission to the next stage of selection.
- 7. The list of register numbers of candidates who were admitted to Onscreen Certificate Verification and who have not been considered for provisional admission to Oral Test and the reasons there for have been mentioned in the Annexure to this list.
