**COMBINED ENGINEERING SERVICES EXAMINATION

The list of Register Number of candidates who have been provisionally admitted to Oral Test(Phase-II) in the ratio of 1:3 for the posts included in Combined Engineering Services Examination (Interview Posts) based on the results of the written examination conducted by the Commission on 06.01.2024 and 07.01.2024 FN & AN, had been published in the Commission's website on 20.09.2024.

In the II phase of selection of the candidates for the said recruitment after completion of second phase of Oral Test based on post preference of the candidates during Oral Test(Phase-II), eligible candidates for a total of 3 vacancies in the post of Manager – Engineering ,TNCMPFL, are not available.

Hence, the register number of candidates mentioned below has been provisionally admitted to Oral Test(Phase-III), in the ratio of 1:3 based on the marks obtained by the candidates in the said examination, rule of reservation of appointments and other conditions stipulated in the notification for the said recruitment.

The Oral Test (Phase-III) will be held on 06.12.2024 at the office of the Tamil Nadu Public Service Commission, TNPSC Road, Chennai - 600 003. The candidates should attend the said Oral Test with all original certificates in support of the claims made in their online

application. The above details will be made available in the Commission's website and the candidates will be informed of the above fact only through SMS and e-mail accordingly. Individual communication regarding the date and time of the said Oral Test will not be sent to the candidates by post.

No individual communication shall be sent to the candidates by Post. The Commission shall not be responsible if the communication does not reach the applicant due to incorrect / invalid e-mail ID /mobile number and failure / delay in delivery of SMS / e-mail to the candidates due to any reason including technical issues. Any representation from the candidates for non-receipt of SMS or e-mail will receive no attention.

Note:-

1. **Mere inclusion of the register number of a candidate in the above list does not imply that his/her candidature has been fully considered for Oral Test(Phase-III) and next stage of selection.**
2. The candidates whose register number is found in the above list, have been admitted provisionally to the Oral Test(Phase-III) based on the marks obtained by them in the written examination,

rule of reservation of appointments and other conditions stipulated in the notification for the said recruitment.

3. The admission of candidates to Oral Test(Phase-III) is provisional subject to verification and acceptance of the claims as made in their online application towards Age, Gender, Educational Qualification, Experience, Communal category, PSTM, Differently Abled category etc., through original documents. If any of their claims is found to be false or incorrect, their online application will be rejected, their provisional admission to Oral Test(Phase-III) will be cancelled and they will not be admitted to the next stage of selection.
4. The candidates who have appeared for the said written examination and whose register number is not found in the above list have not been admitted to the Oral Test(Phase-III) for the said recruitment.
5. The admission of candidates to Oral Test (Phase-III) is purely provisional subject to the decision of the Hon'ble Commission and final orders in W.P.Nos.27448, 26133, 26136, 16169, 19493, 3563 of 2024,W.A.No.2798/2024, W.A.(MD) No.181 of 2023 & CMP (MD) No.2247 of 2023 and other cases relating to this recruitment, if any, pending on the files of the Hon'ble High Court of Judicature at Madras / Madurai Bench of Madras High Court.
6. The candidates who have been admitted provisionally to the Oral Test(Phase-III) are hereby advised to attend the same with all the relevant documents, in original without fail. Failure to produce even any one of the essential documents will result in their non-admission to the next stage of selection.

7. Certain candidates who had been selected in Phase-I of the recruitment / provisionally admitted to OT(Phase-I & II)/ not reached the zone of consideration for OT (Phase-I and Phase-II) have now been admitted to Oral Test (Phase-III) for the post of Manager – Engineering ,TNCMPFL, based on the marks in the said written examination and other conditions stipulated in the notification for the said recruitment.
