The admission of the above candidates to the Oral Test / Physical Certificate Verification and Oral Test is purely provisional subject to the decision of the Commission and subject to the final orders to be passed in W.A. No.181 of 2023 and C.M.P.(MD) No.2247 of 2023 and W.P.No.2168/2023 and other cases relating to this recruitment, if any, pending on the files of the Hon'ble High Court of Judicature at Madras / Madurai Bench of Madras High Court.
- 6. Candidates who have been admitted provisionally to the Oral Test / PCV and OT are hereby advised to attend the Oral Test / PCV and OT with all the relevant documents, in original without fail. Failure to produce even any one of the essential documents will result in their non-admission to the next stage of selection.
