POSTS INCLUDED IN THE COMBINED RESEARCH ASSISTANT IN VARIOUS SUBORDINATE SERVICES LIST - OT

The list of register number of candidates admitted provisionally to Onscreen Certificate Verification in the ratio of 1:4 for the posts included in Combined Research Assistant in Various Subordinate Services (Interview Posts) was published on the Commission's Website on 14.11.2023 based on the results of the written examination (Computer Based Test) conducted by the Commission on 09.09.2023 AN and 10.09.2023 FN.

The oral test will be held on 22.01.2024 at the office of the Tamil Nadu Public Service Commission, TNPSC Road, Chennai- 600 003. The candidates should attend the oral test with all original certificates in support of the claims made in their online application. The above details will be made available in the Commission's website and the candidates will be informed of the above fact only through SMS and e-mail. Individual communication regarding the date and time of oral test will not be sent to the candidates by post.

Any representation from the candidates for non-receipt of SMS or e-mail will receive no attention

NOTE:

- As per Note 3 under sub division 2 of para 10 (selection procedure) of the Commission's Notification No.13/2023 dated 26.06.2023, selection in respect of Non-Interview posts will be taken up after finalizing the selection for Interview posts.
- 2. Mere inclusion of the register number of candidates in the above list does not imply that their candidature has been fully considered for next stage of selection.
- 3. The candidates whose register number is found in the above list have been admitted provisionally to the Oral Test based on the marks obtained by them in the examination (Computer based Test) , reference to the rule of reservation of appointment and other conditions stipulated in the notification for the said recruitment.
- 4. The admission of candidates to Oral Test is provisional subject to verification and acceptance of the claims as made in their online application towards Age, Educational Qualification, Communal category, PSTM and Differently Abled category etc., through original documents. If any of their claims are found to be false or incorrect, their online application will be rejected, their

provisional admission to Oral Test will be cancelled and they will not be admitted to the next stage of selection.

- 5. The candidates who have appeared for Computer Based Test and whose register numbers are not found in the above list have not been admitted to the Oral Test.
- 6. The admission of the above candidates to the Oral Test is purely provisional subject to the final orders to be passed in W.A.(MD) No.181 of 2023 and CMP (MD) No.2247 of 2023 pending before the Hon'ble Madurai Bench of Madras High Court and others cases relating to this recruitment, if any pending on the files of the Hon'ble High Court of Judicature at Madras / Madurai Bench of Madras High Court.
- 7. Candidates who have been admitted provisionally to the Oral Test are hereby advised to attend the Oral Test with all the relevant documents, in original without fail. Failure to produce even any one of the essential documents will result in their non-admission to the next stage of selection
