Individual Communication regarding the date and time of Certificate Verification / Oral Test will not be sent to the candidates by post. The above details will be made available in the Commission's website and the candidates will be informed of the above fact only through SMS and e-mail accordingly.

The admission of candidate with register number **100001005** to Certificate Verification / Oral Test is purely provisional subject to verification /acceptance of the documents in support of the claims in his/her online application in respect of Age, Educational Qualification, Communal Category, Experience, etc. Only after verification, his/her eligibility will become final for admission to Oral Test (Interview). If he/she does not produce the required certificates or if he/she does not satisfy the eligibility criteria his/her online application will be rejected and his/her provisional admission to Oral Test will be cancelled. Mere inclusion of the Register Number of candidate in this list will not confer any right on the part of candidate to claim any right for participation in Oral Test (Interview).

Notes:

1. Mere inclusion of the Register Numbers of candidates will not imply that his / her candidature has been fully considered for next stage of selection.
2. The candidates whose Register Numbers are found in the above list have been admitted provisionally to the Certificate Verification based on the marks obtained by them in the Written Examination and with reference to the Commission's notification No.04/2019 dated 10.01.2019 which has been notified as per the orders of the Hon'ble High court of judicature at Madras in W.P.No.2937 of 2018. Cont.P.no.1773 of 2015 and W.M.P.No.3599 of 2018.
3. The admission of the candidates to the Certificate Verification / Oral Test is provisional subject to the verification and acceptance of the claim in their online applications towards Age, Educational Qualification, Communal Category, Experience, etc., through original documents. If any of their claims are found to be false or incorrect, their provisional admission to Certificate Verification / Oral Test will be cancelled and they will not be admitted to the next stage of selection.
4. The candidates who have appeared for Written Examination and whose register numbers are not found in the above list have not been admitted to the Oral Test.
5. The admission of the above candidates to the Certificate Verification / Oral Test is purely provisional subject to the decision of the Commission and subject to the outcome or final orders to be passed by the Hon'ble High Court of Judicature at Madras in the WPs and other cases relating to this recruitment, if any, pending on the files of the Hon'ble High Court, Madras / Madurai Bench of Madras High Court.
6. Candidates who have been admitted provisionally to the Oral Test are hereby advised to attend the Oral Test with all the relevant documents without fail. Failure to produce even any one of the essential documents will result in their non-admission to Oral Test.
7. The list of register number of candidate who was admitted to Certificate Verification and who has not been considered for provisional admission to Oral Test and the reasons therefor have been mentioned in the Annexure to this list.
