**EXECUTIVE OFFICER, GRADE - III IN THE TAMIL NADU HINDU RELIGIOUS  
AND CHARITABLE ENDOWMENTS SUBORDINATE SERVICE

Based on the results of the written examination for 24 vacancies in the post of **Executive Officer, Grade - III in the Tamil Nadu Hindu Religious and Charitable Endowments Subordinate Service included in Group-VII-B Service** conducted by the Commission on 04.11.2012 FN & AN, for one unfilled vacancy in the category of BC\_ Ex-Ser\_PSTM, two lists of 5 and 11 register numbers provisionally admitted to Certificate Verification were published on 05.12.2013 and 12.06.2015 respectively. Further, list of 3 register numbers provisionally admitted to Certificate Verification/Oral Test was published on 22.02.2017. Finally available 4 candidates were called for Certificate Verification on 17.03.2017. Consequent to that, based on their eligibility, the following is the list of Register Numbers of candidates who have been admitted provisionally to Oral Test. The Oral Test (Interview) will be held on **02.06.2017**, at the office of the Tamil Nadu Public Service Commission, Frazer Bridge Road, Chennai - 600003. **Notes:**

1. Mere inclusion of the Register Numbers of candidates will not imply that his/her candidature has been fully considered for Oral Test.

2. The candidates whose Register Numbers are found in the above list have been admitted provisionally to the Oral Test based on the marks obtained by them in the Written Examination, Educational Qualification possessed by them and with reference to the rule of reservation of appointments. The admission of the above candidates to the Oral Test is purely provisional subject to verification and acceptance of the claim in their online applications towards Age, Educational Qualification, Community, PSTM, Ex-servicemen, etc. through original documents. If any of their claims are found to be false or incorrect, their provisional admission to Oral Test will be cancelled and they will not be admitted to the Oral Test.
3. The admission of the above candidates to the Oral Test is purely provisional subject to the decision of the Hon'ble Commission and subject to the final orders to be passed by the Hon'ble High Court of Judicature at Madras in the WPs and other cases pending on the files of the Hon'ble High Court, Madras / Madurai Bench of Madras High Court, if any, relating to this recruitment.
4. Candidates who have been admitted provisionally to the Oral Test are hereby advised to attend the Oral Test with all the relevant documents in original, without fail. Failure to produce even any one of the essential document will result in their non-admission to the Oral Test.
