Two lists of candidates admitted provisionally to certificate Verification for the post of **Executive Officer, Grade-IV in the Tamil Nadu Hindu Religious and Charitable Endowments Subordinate Service included in Group-VIII Services (2014-2015, 2015-2016 & 2016-2017)** were published in the Commission's website on 26.10.2017 and 27.11.2017 based on the results of the written examination conducted by the Commission on 11.06.2017 FN & AN

During the 1st & 2nd phases of Certificate Verification held on 13.11.2017&14.11.2017 and 12.12.2017 respectively, 23 candidates were absent, the application of 1 candidate was rejected and the status of 4 candidates has changed.

After the 1st & 2nd phases of Certificate Verification, the candidates whose Register numbers are mentioned below have been provisionally admitted to Oral Test in the ratio of 1:2/1:3. The Oral Test will be held on **03.01.2018**, at the Office of the Tamil Nadu Public Service Commission, Frazer Bridge Road, Chennai – 600 003.
