### **District Educational Officer in the Tamil Nadu School Educational Service (2012)**

The List-I and List-II comprising of Register numbers of 35 candidates and 15 candidates respectively who had been provisionally admitted to Certificate Verification relating to the post of **District Educational Officer in the Tamil Nadu School Educational Service (2012)**, were published in the Commission's website on 10.11.2016 and 16.12.2016 based on the results of the written examination conducted by the Commission on 06.08.2015 FN, 07.08.2015 FN & 08.08.2015 FN.

During the 1<sup>st</sup> Phase of Certificate Verification held on 21.11.2016, one candidate was not considered for further process and 6 candidates were found ineligible for teacher vacancies as mentioned in Annexure. Hence, it was decided by the Commission to admit all the candidates who have claimed in the online applications with regard to teaching experience after acquiring B.T or B.Ed qualification. Hence, apart from the candidates who had already completed the certificate verification, 15 candidates were admitted provisionally to the 2<sup>nd</sup> phase of certificate verification for the said post.

During the 2<sup>nd</sup> Phase of Certificate Verification held on 27.12.2016, 14 candidates mentioned in the Annexure were found ineligible for said post.

Hence, after the 1<sup>st</sup> Phase and 2<sup>nd</sup> Phase of certificate verification, the candidates whose Register Numbers are mentioned below have been provisionally admitted to Oral Test. The Oral Test will be held on **19.01.2017**, at the office of the Tamil Nadu Public Service Commission, Frazer Bridge Road, Chennai - 600003. The candidates should come to office of the Tamil Nadu Public Service Commission with all original certificates in support of the claims

made in their online applications. Individual intimation regarding the date and time of the Oral Test will be sent to the candidates separately:-

The candidate with Register Number 010010166 has been provisionally admitted to Certificate Verification for Oral Test. If he/she does not produce the required certificates or if he/she does not satisfy the eligibility criteria, his/her provisional admission to Certificate Verification for Oral Test will be cancelled and he/she will not be admitted to Oral Test.

**Notes:**

1. Mere inclusion of the Register Numbers of candidates will not imply that his/her candidature has been fully considered for Oral Test.
2. The candidates whose Register Numbers are found in the above list have been admitted provisionally to the Oral Test based on the marks obtained by them in the Main Written Examination, Educational Qualification, Experience possessed by them and with reference to the rule of reservation of appointments. The admission of candidates to Oral Test is provisional subject to verification and acceptance of the claim in their online applications towards Age, Educational Qualification, Experience, Community, etc, through original documents. If any of their claims are

found to be false or incorrect, their provisional admission to Oral Test will be cancelled and they will not be admitted to Oral Test.

3. The Candidates who have appeared for the Main Written Examination and whose register numbers are not found in the above list have not been admitted to the Oral Test.
4. The admission of the above candidates to the Oral Test is purely provisional subject to the decision of the Commission and subject to the final orders to be passed by the Hon'ble High Court of Judicature at Madras in the W.P.Nos.22160, 22161 & 40776/2016 and other cases pending on the files of the Hon'ble High Court, Madras/Madurai Bench of Madras High Court, if any, relating to this recruitment.
5. Candidates who have been admitted provisionally to the Oral Test are hereby advised to attend the Oral Test with all the relevant documents in original, without fail. Failure to produce even any one of the essential document will result in their non-admission to the Oral Test.
