

POSTS OF PERSONAL ASSISTANT TO HON'BLE JUDGES, PERSONAL ASSISTANT TO REGISTRARS AND PERSONAL CLERK TO THE DEPUTY REGISTRARS INCLUDED IN THE MADRAS HIGH COURT SERVICE

A list-I of 208 candidates provisionally admitted to Certificate Verification for Oral Test for appointment by direct recruitment to the posts of Personal Assistant to Hon'ble Judges, Personal Assistant To Registrars and Personal Clerk to the Deputy Registrars included in the Madras High Court Service was published in the Commission's website on 02.11.2016 based on the results of the written examination conducted by the Commission on 27.08.2016 FN.

During the 1st Phase of Certificate Verification held on 14.11.2016 & 15.11.2016, 36 candidates had absented themselves and the applications of 38 candidates have been subsequently rejected with reference to Oral Test posts. Further, it has been decided by the Commission to admit the candidates to 2nd Phase of Certificate Verification at the ratio of 1:3. Hence apart from the candidates who had already attended the 1st Phase of Certificate verification and found eligible, List II of 92 candidates were provisionally admitted to next phase of Certificate Verification for the said posts.

During the 2nd Phase of Certificate Verification held on 07.12.2016, 14.12.2016 & 19.12.2016, 12 candidates mentioned in the Annexure had absented themselves and the 19 candidates mentioned in the Annexure were found ineligible for Oral Test posts.

Hence, after the 1st Phase and 2nd Phase of certificate verification, the candidates whose Register Numbers are mentioned below have been provisionally admitted to Oral Test for appointment by direct recruitment to the posts of Personal Assistant to Hon'ble Judges, Personal Assistant to Registrars and Personal Clerk to the Deputy Registrars included in the Madras High Court

Service based on the results of the Written Examination conducted by the Commission on 27.08.2016 FN on behalf of the Hon'ble High Court of Madras. The Oral Test will be held from 10.01.2017 to 12.01.2017, at the office of the Tamil Nadu Public Service Commission, Frazer Bridge Road, Chennai - 600003. The candidates whose Register Numbers are found in the above list have been admitted provisionally to the Oral Test based on the marks obtained by them in the Written Examination, Educational Qualification, Technical Qualification possessed by them and with reference to the rule of reservation of appointments. The admission of candidates to Oral Test is provisional subject to verification and acceptance of the claim in their online applications towards Age, Educational Qualification, Technical Qualification, Community, Differently Abled Status, PSTM etc, through original documents. If any of their claims are found to be false or incorrect, their provisional admission to Oral Test will be cancelled and they will not be admitted to Oral Test.
- 3. The Candidates who have appeared for the Written Examination on 27.08.2016 FN and whose register numbers are not found in the above list have not been admitted to the Oral Test.
- 4. 17 Candidates whose register numbers have been mentioned in annexure and who have already attended the Certificate Verification have not reached the zone of consideration for admission to Oral Test.
- 5. The admission of the above candidates to the Oral Test is purely provisional subject to the decision of the Commission and subject to the final orders to be passed by the Hon'ble High Court of Judicature at Madras in the WPs and other cases pending on the files of the Hon'ble High Court, Madras/Madurai Bench of Madras High Court, if any, relating to this recruitment.
- 6. Candidates who have been admitted provisionally to the Oral Test are hereby advised to attend the Oral Test with all the relevant documents in original, without fail. Failure to produce even any one of the essential document will result in their non-admission to the Oral Test.
