The list of candidates provisionally admitted to Oral Test for the post of **ARCHITECTURAL ASSISTANT / PLANNING ASSISTANT IN THE TAMIL NADU TOWN AND COUNTRY PLANNING SUBORDINATE SERVICE (2007 - 2015)** was published in the Commission's website on 23.05.2019, based on the results of the written examination conducted by the Commission on 22.12.2018 FN & AN.

One vacancy in SCA Woman PSTM category could not be filled up due to paucity of candidates who have secured the minimum qualifying marks in that category. Hence, the candidates whose Register Numbers mentioned below have been provisionally admitted to Certificate Verification/Oral Test in the ratio of 1:3 against the vacancy in the said category. The **Certificate Verification/Oral Test** will be held on **05.08.2019 AN**, at the office of the Tamil Nadu Public Service Commission, TNPSC Road, Chennai - 600 003. The candidates should attend the Certificate Verification/Oral Test with all original certificates in support of the claims made in their online applications. Individual Communication regarding the date and time of Certificate Verification/Oral Test will not be sent to the candidates by post. The above details will be made available in the Commission's website and the candidates will be informed of the above fact only through SMS and e-mail accordingly.

The admission of the said candidates to Certificate Verification / Oral Test is purely provisional subject to verification / acceptance of the documents in support of the claims in his/her online application in respect of Age, Educational Qualification, Communal Category etc. Only after verification, his/her eligibility will become final for admission to Oral Test (Interview). If he/she does not produce the required certificates or if he/she does not satisfy the eligibility criteria his/her provisional admission to Oral Test will be cancelled. Mere inclusion of the Register Number of candidate in this list will not confer any right on the part of candidates to claim any right for participation in Oral Test (Interview).

Notes:-

1. **Mere inclusion of the Register Numbers of candidates will not imply that their candidature has been fully considered for next stage of selection.**
2. The candidates whose Register Numbers are found in the above list have been admitted provisionally to the Certificate Verification/Oral Test based on the marks obtained by them in the Written Examination. The admission of candidates to Certificate Verification/Oral Test is provisional subject to verification and acceptance of the claim in their online applications towards Age, Educational Qualification, Community, PSTM etc., through original documents. If any of their claims are found to be false or incorrect, their provisional admission to Certificate Verification/Oral Test will be cancelled and they will not be admitted to the Oral Test.
3. The admission of the above candidates to the Certificate Verification/Oral Test is purely provisional subject to the decision of the Commission and subject to the final orders to be passed by the Hon'ble High Court of Judicature at Madras in the WP No. 5436/2019 and other cases pending on the files of the Hon'ble High Court, Madras/Madurai Bench of Madras High Court, if any, relating to this recruitment.
4. Candidates who have been admitted provisionally to the Certificate Verification/Oral Test are hereby advised to attend the Certificate Verification/Oral Test with all the relevant documents without fail. Failure to produce even any one of the essential document will result in their non-admission to Certificate Verification/Oral Test.
