The admission of candidate with register number **100001073** to Certificate Verification/Oral Test is purely provisional subject to verification/acceptance of the documents in support of the claims in his/her online application in respect of Age, Educational Qualification etc. Only after verification, his/her eligibility will become final for

admission to Oral test (Interview). If he/she does not produce the required certificates or if he/she does not satisfy the eligibility criteria his/her online application will be rejected and his/her provisional admission to Certificate Verification/Oral Test will be cancelled. Mere inclusion of the Register Number of candidate in this list will not confer on the part of candidate any right for participation in Oral Test (Interview).

NOTES:

1. Mere inclusion of the Register Numbers of candidates in the above list will not imply that their candidature has been fully considered for next stage of selection.
2. The candidates whose Register Numbers are found in the above list have been admitted provisionally to the Certificate Verification/Oral Test based on the marks obtained by them in the Written Examination.
3. The admission of the candidates to the Certificate Verification/Oral Test is provisional subject to the verification and acceptance of the claim in their online applications towards Age, Educational Qualification etc., through original documents. If any of their claims are found to be false or incorrect, their provisional admission to Certificate Verification/Oral Test will be cancelled and they will not be admitted to the next stage of selection.
4. The candidates who have appeared for Written Examination and whose register numbers are not found in the above list have not been admitted to the Certificate Verification/Oral Test.
5. The admission of the above candidates to the Certificate Verification/Oral Test is purely provisional subject to the decision of the Commission and subject to the outcome or final orders to be passed by the Hon'ble High Court of Judicature at Madras in the WPs and other cases relating to this recruitment, if any, pending on the files of the Hon'ble High Court, Madras / Madurai Bench of Madras High Court.
6. Candidates who have been admitted provisionally to the Certificate Verification/Oral Test are hereby advised to attend Oral Test with all the relevant documents without fail. Failure to produce even any one of the essential documents will result in their non-admission to the Oral Test.
7. The list of register numbers of candidates who were admitted to Certificate Verification and who have not been considered for provisional admission to Oral Test and the reasons therefor have been mentioned in the Annexure to this list.
