Sub: Public Services - Preparation of panel for appointment by promotion / Recruitment by transfer - Further guidelines - Issued.

I am directed to invite your attention to the references cited. In the reference first cited, detailed guidelines for preparation of panel were issued. Subsequently, in the reference second cited, specific guidelines were issued with regard to the pendency of Vigilance Enquiry / Charges, effect of adverse remarks in Personal file / Confidential Report and specific punishments for adoption while preparing panels. In the letters third and fourth cited, further guidelines were issued to the instructions issued in paragraph 4 II(2) and paragraph 4 II(3) of the letter second cited.

2. The instructions issued in the leters third and fourth cited are inter-related to each other. As they are read separately, it has been decided to issue clear guidelines in this regard. Hence the following Amendment is issued to Letter Ms.No.248. Personnel and Administrative Reforms (S) Department dated 20.10.97 read with Letter No.52511/S/99-1, Personnel and Administrative Reforms (S) Department, dated 1.10.99.

## **AMENDMENT**

The existing proviso 1 to para 4 II (2) shall be substitued as follows:-

"Provided that if the officer was imposed with any of the punishments within the check period as mentioned above for irregularities / delinquencies which occurred five years prior o the crucial date, such punishment need not be held against him, if such penalty is not in currency on the crucial date and also on the date of consideration of the panel ".
