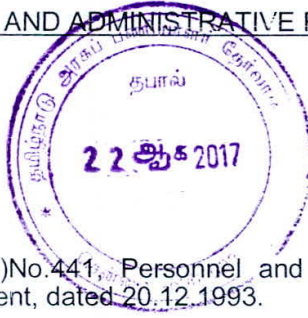

ORDER:

The proposal for recognition of the M.Sc., (Statistics and Informatics) awarded by Bharathidasan University as Equivalent to M.Sc., (Statistics) for the post of Assistant/ Assistant Section Officer in the Finance Department, Secretariat and for the Post of Senior Research Assistant in the office of the Tamil Nadu Public Service Commission was placed before the 29th Equivalence Committee meeting held on 25.01.2011.

2. The Equivalence Committee resolved to recommend that the M.Sc., (Statistics and Informatics) awarded by Bharathidasan University as Equivalent to M.Sc., (Statistics) for the post of Assistant/ Assistant Section Officer in the Finance Department, Secretariat and for the Post of Senior Research Assistant in the office of the Tamil Nadu Public Service Commission.

Accordingly, in the Government Order third read above, orders were issued that the candidates with qualification in M.Sc., (Statistics and Informatics) awarded by Bharathidasan University are eligible for appointment for the post of Assistant / Assistant Section Officer in the Finance Department in the Tamil Nadu Secretariat Service.

4. In the letter fourth read above, the Secretary, Tamil Nadu Public Service Commission has requested to issue orders on the above Resolution of the Equivalence Committee with regard to the post of Senior Research Assistant in the office of the Tamil Nadu Public Service Commission.
