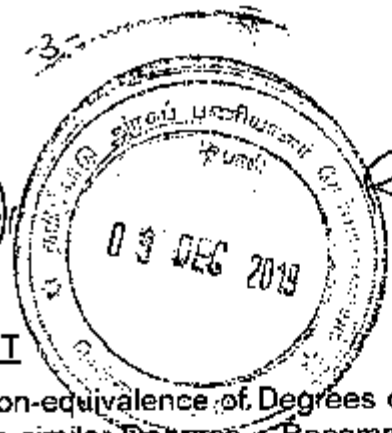

**ORDER:-**
