grade or any post borne on the cadre thereof unless he possesses such special qualifications and has passed such special tests as may be prescribed in that behalf in the special rules; or possesses such other qualifications as have been declared to be higher than or equivalent to the said special qualifications or special tests by the Government in consultation with the Committee constituted under the Chairmanship of the Chairman, Tamil Nadu Service Commission for the purpose, in cases where the appointment has to be made in consultation with the Commission; and by the Government or by the appointing authority with the approval of the Government in other cases along with the explanations therein" as per Section 25 of the Tamil Nadu Government Servants (Conditions of Services) Act, 2016.
