ORDER:-

In the letter second read above, the Member Secretary, Tamil Nadu State Council for Higher Education, has forwarded the resolutions passed by the 10th Equivalence Committee dated 28.10.2021, held under the Chairmanship of the Principal Secretary to Government, Higher Education Department, on the non-equivalence of Degrees offered by the Universities / Educational Institutions to the similar Degrees and requested the Government to issue orders in the matter.

2. The Government, after careful consideration, approve the following resolutions passed in the 10th Equivalence Committee dated 28.10.2021 under the Chairmanship of the Principal Secretary to Government, Higher Education Department and direct that the following Degrees offered by the various Universities / Educational Institutions be not equivalent to the Degrees mentioned therein:-
