## ORDER:

The Equivalence Committee in its 49<sup>th</sup> meeting held on 10.09.2014 has examined the requests of the Universities and Educational Institutions for recognition of the courses offered by them for the purpose of appointments in Public Services and for Higher Studies and after detailed deliberations, the following resolution was passed inter alia vide reference 1<sup>st</sup> read above:-

2. The Registrar, Tamil Nadu Agricultural University in his letter 2<sup>nd</sup> read above has informed that as per the recommendations of the Board of Studies of Agriculture and Forestry, the under graduate programmes B.Sc., (Agriculture) and B.Sc., (Forestry) offered at Tamil Nadu Agricultural

University, Coimbatore are not equivalent. The resolution on Agenda No.11 passed at the Tamil Nadu Public Service Commission's 49<sup>th</sup> Equivalence Committee Meeting held on 10.09.2014 is in line with recommendations of the Board of Studies. Hence, the Registrar, Tamil Nadu Agricultural University has stated that B.Sc., (Agriculture) is not equivalent to B.Sc., (Forestry).

3. The Government, after careful consideration, have decided to accept the recommendation of the Equivalence Committee as endorsed by the Registrar, Tamil Nadu Agricultural University and accordingly direct that the degree of B.Sc., (Agri) awarded by Tamil Nadu Agricultural University is not equivalent to the degree of B.Sc., (Forestry) for the purpose of appointments in Public Services and for higher studies.
